- 1) The financial results of the Company have been prepared in accordance with Indian Accounting Standards (Ind AS) notified under the Companies (Indian Accounting Standards) Rules, 2015 as amended by the Companies (Indian Accounting Standards) (Amendment) Rules, 2016.
- 2) The above Financial Results for the Quarter ended June 30, 2018 have been reviewed by the Audit Committee and on their recommendation have been approved by the Board of Directors at their respective meetings held on August 14, 2018. The statutory auditors of the Company have reviewed the above standalone for the quarter ended June, 2018. Further in accordance with the requirements under Regulation 33 of the SEBI (LODR) Regulations, 2015, the statutory auditors have carried out limited review report for the quarter ended June 30, 2018 and the report has been approved by the Board.
- 3) Effective April 1, 2018, the company has applied Ind AS 115 "Revenue from Contracts with Customers". The standard is applied retrospectively with the cumulative effect of initially applying the standard recognized as an adjustment to opening equity at the date of initial application. The adoption of Ind AS 115 did not have any significant impact on the overall results of the Company.
- 4) Figures for the quarter ended 30th June, 2017 have been reclassified, wherever necessary to make them comparable with the figures for the current period.
- 5) Calculation of Deferred Tax will be made at the year end.
- 6) Further, pursuant to Regulation 33(3) of Listing Regulations, we hereby opt not to submit the quarterly and year to date Consolidated financial results in relation to the quarters of First, Second and Third the financial year 2018-19. However, the Company will submit the Standalone quarterly and year to date financial results in relation to the aforesaid quarters as per usual practice followed.
